Kids SmART Fall 2020 Full Day/Remote Learning Support Program Update

To the Communities and Families of Kids SmART:

As most of you are aware of, both Jefferson and Denver Public Schools have updated their announcement and have decided to follow their "remote/online learning" plan through at least September 4, 2020. Kids SmART, along with several of our school community partners agree that despite our agreement that while this remote option is the best for the community as a whole, we believe child care and remote learning support programs need to reopen for at least some of our families.

With the support and collaboration of these schools, Kids SmART will be opening full day programming from 7:30a-5:00pm Mon-Fri effective August 17 for children 5yrs and older at the following tentative school locations:

- Slater Elementary -8605 W 23rd Ave Lakewood (License # 1734755)
- Thomson Elementary 7750 Harlan St Arvada (License # 1737252)
- Wilmore Davis Elementary -7975 W 41st Ave Wheat Ridge (License # 1614550)
- Additional site locations may be announced based on need *Locations will be finalized once registration is complete and sufficient enrollment is confirmed.

We will be working closely with each of the individual schools to ensure our ability to offer proper space and safety guidelines that align with the current recommendations outlined by the State and County Health departments. This will include minimizing group cohorts to 15 children, not intermingling groups throughout each week, offering care outside whenever possible, and implementing strict safety and cleaning guidelines at each of our approved sites.

Virtual registration for the FULL DAY PROGRAMS ONLY will be open Monday, August 3, 2020 @ 8am through Friday, August 7, 2020 @ 4pm. In order to register for this full day programming, you must submit the following documents either via email: admin@kids-smart.com or fax: 720-550-6729:

- Completed enrollment packet (total of 3 pages)
- Copy of immunizations
- Notice of full day program location desired (list on enrollment form and tuition calendar)
- Submit August tuition calendar- payment for August will be collected once space is confirmed
- Submit \$50/child;\$100/family registration fee (CCAP families exempt)

Please remember that space is extremely limited and weekly spots will be reserved on a first scheduled/first paid basis. Once your registration is confirmed, we strongly encourage you to pay for the weeks of care needed in August to reserve your child's spot in our program. Latest payment for the week of Aug 17-21 is August 12 unless we reach capacity prior to that.

Please review our full day flyer and COVID-19 policy addendum for additional information surrounding this new full day programming. As always, thank you for your patience as we navigate through this ever-changing situation and do everything we can to get back to working with your kiddos again!
